

CONTRACT AGREEMENT

(as per GPPB Resolution No. 16-2020)

Invitation to Bid No.: IB23-408235-04

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT (herein referred to as "Agreement") made this **DEC 28 2023** day of **2023** between **DEVELOPMENT ACADEMY OF THE PHILIPPINES** of Pasig City, Philippines (hereinafter called "**DAP**") of the one part and **DGL VERACITY SYSTEMS CORPORATION** of Quezon City, Philippines (hereinafter called "**DVSC**") of the other part.

WHEREAS, the **DAP** invited Bids for certain goods and ancillary services, particularly "**ONE (1) LOT SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, TESTING & COMMISSIONING, AND UPGRADING OF THE CLOSED-CIRCUIT TELEVISION SURVEILLANCE SYSTEM AT DAP CONFERENCE CENTER IN TAGAYTAY**" and has accepted a Bid by **DVSC** for the supply of those goods and services in the sum of **THREE MILLION TWO HUNDRED SEVENTY THOUSAND PESOS [P3,270,000.00]** (hereinafter called "**the Contract Price**"), inclusive of VAT.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Official Bidding Documents (OBDs):
 - i. Schedule of requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contracts;
 - iv. Bid Bulletin No. 1 dated October 20, 2023 (**ANNEX "A"**); and,
 - v. Bid Bulletin No. 2 dated October 31, 2023 (**ANNEX "B"**)
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (**ANNEX "C"**);

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the **DAP's** bid evaluation;


- iii. Performance Security in compliance with Section 39 of the 2016 Revised IRR of RA 9184 (**ANNEX "D"**);
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto (**ANNEX "E"**); and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the OBDs. The winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **THREE MILLION TWO HUNDRED SEVENTY THOUSAND PESOS [P3,270,000.00]** inclusive VAT or such other sums as may be ascertained, **DGL VERACITY SYSTEMS CORPORATION** agrees to supply and install those goods and services in accordance with his/her/its Bid.
 4. The **DAP** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


