- **01.** *WHEREAS*, on 27 October 2023 (Thu), an Invitation to Bid¹ for the above-stated Project was posted on the PhilGEPS Website, the DAP Website, the Facebook Page of the BAC Secretariat, and conspicuous places in DAP-Pasig;
- **02.** *WHEREAS*, representatives from four (4) oversight agencies and various organizations were invited to observe the conduct of the bidding process, namely:
 - a. Ms. Suzette G. Pornales, DAP Auditor, Commission on Audit (COA);
 - b. Atty. Howard Randy A. Arzadon, Assistant Government Corporate Counsel-Team 1, Office of the Govt. Corp. Counsel (OGCC);
 - c. Mr. Ruben J. Pascual, Security General, Philippine Chamber of Commerce & Industry (PCCI);
 - d. Mr. Vincent T. Lazatin, Executive Director, Transparency and Accountability Network (TAN); and
 - e. Mr. Victorio Mario Dimagiba, President, Laban Konsyumer Inc. (LKI).
- **03.** *WHEREAS*, on 08 November 2023 (Wed), a Pre-Bid Conference via the Google Meet platform was conducted through the link: <u>meet.google.com/emb-arym-zra</u> and was attended by the Two (2) Prospective Bidders, namely:
 - a. New Trends International Corporation (NTIC); and
 - b. Emporium Retail & Services
- 04. WHEREAS, among the named Prospective Bidders, only NTIC bought the Official Bidding Documents last November 13, 2023, with DAP Official Receipt (OR) Number 0034583² amounting to Two Thousand Pesos (P2,000.00);

- **05.** *WHEREAS*, on 21 November 2023 (Tuesday) the BAC 2 conducted the Submission and Opening of e-Bids (SOeB) via the Google Meet platform through the link: <u>meet.google.com/fvi-psvq-tgn</u>, wherein no bidder participated and submitted bids on the public competitive bidding for the transaction. Observers who attended during the SOeB were Mr. Gelie Abinoja from DAP-COA and Atty. Eunice Guadalope from OGCC;
- 06. WHEREAS, the BAC Secretariat received a Letter of Regret³ from NTIC for the said Project;
- 07. WHEREAS, pursuant to Section 35 (a) of 2016 Revised Implementing Rules and Regulations of RA 9184, BAC 2 declared that the bidding for this transaction was "FAILED" on the reason that "No bids are received" on the scheduled date and time of the Submission and Opening of Bids.
- **08.** *NOW, THEREFORE,* we, the members of the BAC2 as per SO No. 2023-047, hereby RESOLVED:
 - a. To declare a FAILURE OF BIDDING for this Project; and
 - b. To recommend to the HoPE the 1st FAILURE OF BIDDING and to RE-BID pursuant to Section 35 of the 2016 Revised IRR of RA 9184.


