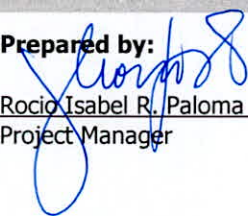

Secure as many participants as possible.

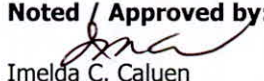
